As of March 31, 2024, the current period total sales were \$10,195.99. The total cost of sales was \$4,724.94, resulting in a gross profit of \$5,471.05. Total operating expenses were \$3,462.80, leaving an operating profit of \$2,008.25. Interest income was \$50.64, resulting in a net profit of \$2,058.89. Total assets as of March 31, 2024, from checking/savings/other equaled \$171,594.67.
